

This contract is between Tiffany Jones, d/b/a Doodles Kennel ("Seller"), and the buyer identified below ("Buyer"), and is entered into as of the date below.

SELLER'S RESPONSIBILITIES

1. Tiffany Jones guarantees the puppy is in good health, has had its up-to-date immunizations, and has been de-wormed at the time the Buyer takes possession. The Buyer has three business days to take the puppy to a veterinarian for examination. If the puppy is found to be in poor health, the Buyer may return the puppy to the Seller, at the Buyer's cost, for a full refund. The Buyer must provide a written statement from a licensed veterinarian clearly stating the defect or illness. If the puppy is not taken to a licensed veterinarian within the three business days, this health warranty is void.
2. Tiffany Jones provides this warranty for two years after the date of sale against any debilitating congenital defects. If the puppy exhibits symptoms of a suspected debilitating congenital defect, the Buyer must supply any requested veterinary records to the Seller within seven days of informing the Seller of the defect. Tiffany Jones has the right to require a second opinion from a veterinarian of the Seller's choice, at the Seller's expense. If the puppy is euthanized or otherwise disposed of without a second opinion from the Seller's veterinarian, the Buyer waives all rights to a replacement puppy.
3. This warranty does not include viral illnesses, infections, improper bites, hernias, hypoglycemia, Giardia, or Coccidiosis. It also does not include any illness due to the ingestion of foreign objects, food, or chemicals, or due to physical injury.
4. If it is determined the puppy has a genetic disorder identified within two years of purchase, the Buyer has the option of a replacement puppy from the next available litter. The original puppy need not be returned, provided there is documented support of the medical condition. Shipping fees already paid will not be refunded, and if it becomes necessary to ship a replacement puppy, those fees are to be paid by the Buyer.
5. If the puppy should die from a suspected congenital defect within 24 months of its date of purchase, an autopsy must be performed at the Buyer's expense by a licensed veterinarian acceptable to the Seller's veterinarian. If the autopsy shows a congenital defect as the cause of death, the Seller will provide another puppy of equal value to the Buyer. A written statement from the veterinarian must be provided. This warranty is void in the event of an undetermined or inconclusive diagnosis.
6. Tiffany Jones agrees to provide a pedigree and the number of the microchip implanted in the puppy, if applicable.
7. No warranties or guarantees, expressed or implied, are made under this contract except as stated.
8. This warranty is non-transferable.
9. Tiffany Jones agrees to send the registration and pedigree, if requested, to the new owner within 30 days of receiving proof of spay or neuter from a veterinarian.

BUYER'S RESPONSIBILITIES

1. The Buyer agrees to pay Tiffany Jones the Total Purchase Price stated above. This amount does not include shipping or delivery, if shipping or delivery is required.
2. The Buyer bears all costs relating to the sale of the puppy, including transportation. The risk of loss or injury to the puppy is on the Buyer at all times after the puppy leaves the Seller.
3. The Buyer agrees that their Labradoodle will be properly housed with daily outdoor activity.
4. Tiffany Jones highly recommends feeding the Labradoodle only a premium quality food.
5. The Buyer agrees to keep their Labradoodle at a healthy weight.
6. The Buyer agrees to make and keep annual veterinary appointments for their Labradoodle, keep all immunizations current according to American Veterinary Medical Association guidelines, and properly administer heartworm preventative medication.
7. The Seller highly recommends basic obedience training for the Labradoodle puppy within its first year.
8. The Buyer agrees to postpone strenuous, repetitive exercise until the Labradoodle is over one year of age.
9. The Buyer agrees to contact Tiffany Jones immediately if the Buyer determines they are unable to keep their Australian Labradoodle for any reason. The Buyer and Richard Jones will determine how the dog will be re-homed.
10. The Buyer agrees to never place the Labradoodle in a shelter, pound, or similar facility or research laboratory.
11. A deposit is required to place a hold on a puppy, per the Deposit Amount stated above, of which the stated portion is non-refundable for any reason. The deposit is due at signing. The remaining balance is due in cash upon pickup of the puppy.
12. The Buyer agrees to have the puppy neutered or spayed before the age of one year, and shall not breed the dog or allow it to become pregnant or impregnate another dog without explicit written consent from Tiffany Jones. The Buyer will owe a \$10,000 breeder's fee for each and every pregnancy associated with the dog, and shall be responsible for all court costs incurred for the Seller to recover breeder's fees and/or veterinary bills to terminate a pregnancy.
